

CONSENT TO THE PROCESSING OF PERSONAL DATA

By giving this consent to the processing of your personal data, you consent to the processing of your personal data by Fox Hunter SK, s.r.o., ID No.: 44498217, with its registered office at Kaštieľska 2, 821 05 Bratislava (hereinafter referred to as the "Controller") in accordance with the terms and conditions set out below.

SCOPE OF PROCESSING YOUR PERSONAL DATA

The Controller will process your personal data to the extent that you have provided it. In particular, the controller will process your name, surname, e-mail, telephone number, home address.

PURPOSE OF PROCESSING YOUR PERSONAL DATA

The Controller will process your personal data for the purpose of preparation and implementation of the event.

LEGAL BASIS FOR PROCESSING PERSONAL DATA

The legal basis for the processing is this consent and the fact that your personal data is necessary for the fulfilment of the individual purposes. Personal data is processed in accordance with the General Data Protection Regulation - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 - (hereinafter referred to as "GDPR").

DURATION OF THE PROCESSING OF YOUR PERSONAL DATA

The Administrator will process your personal data in connection with the implementation of the event until 30.10.2024.

WITHDRAWAL OF CONSENT TO THE PROCESSING OF PERSONAL DATA

You may withdraw your voluntary consent to the processing of personal data at any time, free of charge, by sending an email to: office@foxhunter.sk. Withdrawal of consent does not affect the lawfulness of processing based on consent given prior to its withdrawal. The withdrawal of consent also does not affect the processing of personal data that the controller processes on a legal basis other than consent.

PERSONS WITH ACCESS TO YOUR PERSONAL DATA

Your personal data will be accessible by the controller, its employees and, where applicable, third party processors whose processing complies with all the requirements of the GDPR and who will sufficiently protect your rights and your personal data.

YOUR RIGHTS RELATING TO THE PROTECTION OF YOUR PERSONAL DATA

You have the right to withdraw your consent at any time, to correct or supplement your personal data, to request restriction of processing, to object to or complain about the processing of your personal data, to request data transfer, to access your personal data, to be informed of a personal data breach, erasure and other rights set out in the GDPR.

RIGHT TO FILE A COMPLAINT WITH A SUPERVISORY AUTHORITY

At any time, you may file a complaint regarding the processing of your personal data or the controller's failure to comply with its obligations under the GDPR with a supervisory authority.

The supervisory authority in the Slovak Republic is the Office for Personal Data Protection,
located at Hraničná 12, 820 07 Bratislava.

**OBLIGATION TO PROVIDE PERSONAL DATA. CONSEQUENCES OF NOT PROVIDING

You provide your personal data entirely voluntarily. You are under no obligation to provide it. If you do not provide your personal data, you are not subject to any sanction.
